Hazardous Tree Removal

Hazardous tree removal services provided by agency partners include assessments by arborists, felling of hazard trees, and mulching or disposal of trees (varies by agency).

Through the Private Property Debris Removal Program, New Mexico Department of Transportation is removing hazardous trees. For information, call State Disaster Case Management at (505) 670-4662.

The **Natural Resources Conservation Service** is supporting hazard tree removal through the Emergency

Firewood Distribution
