 - Cannot be tied to Benefit Cost Analysis
 - Includes outreach, education, partnerships, developing higher building codes, critical facility generators, rain and stream gauges, etc.
 - Project Scoping (eligible under BRIC and FMA)

- October 1, 2021 Notice of Interest deadline
- October 7, 2021 Application Development Webinar
- November 1, 2021 Application deadline

Maximizing Funding

In order to maximize all open grant funds, DHSEM will prioritize technical assistance to projects selected for submission to BRIC and FMA first, followed by HMGP-PF, then HMGP as these grants are the first to close.

The Mitigation Unit will provide technical assistance throughout the application period. By the end of November, all sub-applicants will be aware of which funding opportunity each project has been assigned.



BRIC and **FMA** Timelines

- January 1, 2022 Final sub-grant application deadline
- January 28, 2022 Grant Application (DHSEM to FEMA) deadline
- June 2022 FEMA selection of projects for "Further Consideration"
- Fall 2022 Respond to FEMA Requests for Information (RFI)
- December 2022 Grant funds awarded (FEMA to DHSEM)
- January 2023 Sub-grants issued

HMGP-PF and HMGP Timelines

- January 31, 2022 Final HMGP-PF sub-grant application deadline
- March 31, 2022 HMGP-PF application period closes
- April 1, 2022 Final HMGP sub-grant application deadline
- August 5, 2022 HMGP application period closes

Sub-grants are awarded as they meet the FEMA requirements for award.

Only if insufficient applications are submitted during the fall application development period, will DHSEM solicit additional applications
