**Required Documentation for
Certificate of Fitness Application**

*Please review the following information as to all documentation, which will be required to obtain a certificate of fitness for your company. "Certificate of Fitness" means the State Fire Marshall's verification document of a fire protection installation, maintenance and inspection company's competence in the methods and materials of the specific fire system subject to the permit, which is obtained pursuant to 10.25.2 NMAC. Documentation requirements for each discipline are listed below. Please review the requirements and submit all documentation requested. Supporting documentation is **REQUIRED** for both new and renewal applications.*

Automatic Fire Sprinkler Systems, Fire Pumps & Standpipe Systems

To receive a Fire sprinkler endorsement, please provide the following:

1. Completed Certificate of Fitness Application
2. Copy of New Mexico Construction Industries Division **MS-12** (Fire Protection Sprinkler) or MM 98 license for company and qualified party.
NOTE: The qualifying party **must** be on the company payroll and cannot be a subcontractor.
3. Copy of training and education
4. Any Certifications from the manufacturer

Chemical Fire Suppression Systems UL300, FM200, INERGEN Systems, Etc.

To receive a Chemical Suppression System Endorsement, please provide the following:

1. Completed Certificate of Fitness Application
2. Copy of New Mexico Construction Industries Division **MS-14** (Dry Chemical Fire Protection) or MM 98 license for company and qualified party.
NOTE: The qualifying party **must** be on the company payroll and cannot be a subcontractor.
3. Copy of training and education
4. Any Certifications from the manufacturer

Automatic Fire Detection & Alarm Systems

To receive a Fire Detection & Alarm Systems Endorsement, please provide the following:

1. Completed Certificate of Fitness Application
2. Copy of New Mexico Construction Industries Division **ES-3** (Low Voltage Special Systems) or **EE-98** (Residential & Commercial Electrical) license for company and qualified party.
NOTE: The qualifying party **must** be on the company payroll and cannot be a subcontractor.
3. Copy of training and education
4. Any Certifications from the manufacturer

Fire and Smoke Dampers

To receive a Fire and Smoke Dampers Endorsement, please provide the following:

1. Completed Certificate of Fitness Application
2. For mechanically actuated fire and smoke dampers, applicants shall provide documentation of a valid NFPA-Certified Fire Protection Specialist certification or of an approved fire and life safety certification from a program accredited by the American National Standards Institute (ANSI).
3. For electrically actuated fire and smoke dampers monitored by a fire alarm system, applicants shall comply with requirements of Automatic Fire Detection & Alarm Systems listed above.
4. For fire and smoke dampers with both mechanical and electrical components, the applicant inspecting the mechanical components shall provide documentation pursuant to (2) of this section and the applicant inspecting the electrical components shall provide documentation pursuant to (3) of this section.
5. Copy of New Mexico Construction Industries Division **ES-3** (Low Voltage Special Systems) or **EE-98** (Residential & Commercial Electrical) license for company and qualified party.
NOTE: The qualifying party must be on the company payroll and cannot be a subcontractor.
6. Copy of training and education
7. Any Certifications from the manufacturer

Portable Fire Extinguishers

To receive a Portable Fire extinguisher Endorsement, please provide the following:

1. Completed Certificate of Fitness Application
2. Copy of training and education
3. Any Certifications from the manufacturer
4. Provide a ***signed*** and ***notarized*** affidavit on company letterhead that states the company has the ability, equipment and training to re-service and recharge all types of fire extinguishers as per the requirements set forth in latest edition of NFPA 10 Standard for Portable Fire Extinguishers and agrees that its mobile and/or fixed facilities can be inspected at any time during normal business hours, on normal business days, to determine compliance.

If applying for more than one discipline, only one copy of the completed Certificate of Fitness Application will be required for submittal. ***Please include all required documentation. If applying for multiple discipline endorsements please include all required documentation for all disciplines. All supporting documentation is required to be submitted for new and renewal applications. Failure to provide any required documentation, and proper license verification, will result in automatic rejection of the application.***
